\$2,200 2000-2001 Non-Academy Fee for 2018-2019 Season

Fees include coaching and training, goalkeeper training, administration, state cup tournaments (where applicable), field usage, lights, Calsouth/Gaming League registrations and anything else determined by the club officials. The fees service period runs through the completion of team's entered state tournament.

Fees do not include tournament fees, referee fees, travel costs, and uniforms. Uniform purchase can be made at club prices and purchased merchandise is the property of the player.

NO PAY. NO TRAIN - DELINQUENT PAYMENTS TO THE CLUB AND/OR TEAM ACCOUNT WILL RESULT IN THE SUSPENSION OF TRAINING ACTIVITIES.

Payment Plan Options

PLEASE NOTE: All pre-season non-refundable deposits of \$350 (for birth years 2005-2009) will be applied to the first payment.

Option 1 - Three Payments (no discount)

\$1100 received at time of team registration (this amount must be paid when the team is registered)

\$550 received on or before 9/1/18

\$550 received on or before 11/1/18

Option 2 - One Payment (\$200 discount) – May only be taken if NOT taking Tenure Discount**

\$2,000 received by June 22nd at 5:00pm. (Minimum \$1,100 must be paid at time of team registration - \$900 due by June 22nd at 5:00pm). No pre-pay discount for players signing after June 22nd.

** Team account fund must be paid in order to receive \$200 Discount

Tenure Discount – Only applies to 2000 & 2001 teams – Does not apply if receiving financial aid – Cannot be combined with full pay discount.**

3 prior full seasons at RSC - \$100

4 prior full seasons at RSC - \$200

5 prior full seasons at RSC - \$300

6 prior full seasons at RSC - \$400

7 prior full seasons at RSC - \$500

** Full pay discount may be taken if greater than the tenure discount. Cannot take both.

Multiple player family discount*

2nd player **\$100**, 3rd player **\$200**, 4th player **\$300**

***Sibling Discounts do not apply when a sibling is a STARS player, or WVSL recreational league player. Sibling discounts are taken on the last payment if on a 3 pay plan.**

Prorated fee schedule

8/16 – 9/15 Reg fee is **\$1900** (\$950 at Reg & \$950 in 60 days)

9/16 – 10/15 Reg fee is **\$1575** (\$800 at Reg & \$775 in 60 days)

10/16 – 11/15 Reg fee is **\$1250** (\$625 at Reg & \$625 in 60 days)

11/16 – 12/31 Reg-fee is **\$950** (\$475 at Reg & \$475 in 60 days)

1/1 – 1/31 Reg fee is **\$750** (\$375 at Reg & \$375 in 60 days)

2/1 – 2/28 Reg fee is **\$525** (\$275 at Reg & 250 in 60 days)

3/1 – 3/31 Reg fee is **\$325** Due at Reg

After 3/31 Reg is **\$125** Due at Reg

TEAM ACCOUNT

Payment to a team account as determined by the team manager and subject to club approval, not to exceed \$200 at time of registration. Team expenditures may require paying additional amounts later in the season as needed.

FINANCIAL AID AND/OR NON-STANDARD PAYMENT TERMS

Generally, the maximum amount of club aid that will be given to any one player will not exceed 50% of club fees if they qualify through the aid application process. Proof of gross income must be submitted with all aid applications.

REFUND SCHEDULE

DROP/TRANSFER up to 8/31- Refund = Registration paid in excess of \$1,100

DROP/TRANSFER Between 9/1 & 12/31- Refund = Registration Paid in excess of \$1,650

DROP/TRANSFER AFTER 12/31 – NO REFUND
